### 1. Minutes

Approval of November 4, 2025, meeting minutes: Dr. Jones noted that the motion and second to conclude the November 4, 2025 meeting were incorrectly documented. With that correction, the minutes will stand as written.

### 4. Items to be Acted Upon

#### **26-03 Revision to Nutrition & Dietetics Catalog Copy**

Dr. Dietz discussed the requested program revisions. Dr. Dietz requested the changes be made effective Spring 2026. The Council asked if it would be possible to remove “Coordinated Program” in the degree pathway titled “3+2 Pathway to MSDN: Coordinated Program.” Dr. Dietz agreed. The pathway will now be referred to as “3+2 Pathway to MSDN.”

Motion: Dr. Laingen moved to approve Item 26-03 with the requested revisions; seconded by Mr. Cranstoun.

Motion approved (7-0-0).

#### **26-04 Modifications to Certificate in Geographic Information Sciences**

Dr. Laingen presented the proposed modifications. The Council recommended removing language under “Courses Applicable Toward a Specific Concurrent or Future Degree Program” which begins: “Courses in this program may be counted toward any Master’s degree program at EIU...” Dr. Laingen concurred and will resubmit the proposal with the referenced paragraph removed.

Motion: Mr. Cranstoun moved to approve item 26-04 with the requested revision; seconded by Dr. Schaljo. Motion approved (7-0-0).

## 7. Committee Reports

- a. **Graduate Student Advisory Council (GSAC):** Ms. Taylor reported that GSAC elected a new president, and the group hopes to investigate the possibility of staff-level parking passes for graduate assistants, review graduate assistant wages across programs, and work on revising the Council's constitution. The next meeting will be held in January.
- b. **Booth Collaborative Advisory Committee (BCAC):** No questions or comments were made regarding Dr. Kochigina's submitted report.
- c. **Textbook Rental Advisory Committee:** Dr. Schaljo noted that email surveys have been distributed regarding potential changes to the Textbook Rental Service.

## 8. Dean's Report

- a. **Department of Homeland Security (DHS) "Duration of Status" Proposal:** Dean Jacobs shared that DHS is proposing that international graduate students be limited to two years to complete their degrees (four years for undergraduates). Currently, students may receive an additional semester to address academic challenges. A national survey conducted by the National Council on Graduate Studies showed that 85% of international students would not choose to study in the United States if such a rule were implemented. Current international students would be grandfathered unless they leave the country. If they return, previous time spent in the U.S. would count toward the two-year limit.

### Additional Updates (Not Included on Agenda)

- Notifications for Fall Research & Creative Activity Awards and Williams Travel Grants recipients will be distributed this week.
- The Interim Provost and Registrar are developing coding for HyFlex courses so that international students enrolled in HyFlex will have the course transcribed as face-to-face, ensuring compliance with federal limits on online coursework.
