IV. Items Acted Upon:

1. 17-175, CAA bylaws revision.

Dr. Barry Kronenfeld presented the proposal and answered questions of the council.

Dr. Ruholl moved and Dr. Janssen Danyi seconded the motion to open the item for discussion. The motion passed with 9 yes votes and 1 abstention as written.

2. 18-001, BIO 3080G, Behavior of Domestic Animals and their Wild Kin (New Course).

Dr. Switzer presented the proposal and answered questions of the council.

Dr. Kronenfeld moved and Dr. Abou-Zaid seconded the motion to open the item for discussion. The motion passed unanimously with the following revision: Part 2, #3. (A). and #8 grid: Change in wording from "engage" to "apply course content."

3. 18-002, Aging Studies Minor (New Minor).

Dr. O'Rourke presented the proposal and answered questions of the council.

Dr. Ruholl moved and Dr. Janssen Danyi seconded the motion to open the item for discussion. The motion passed unanimously as written.

4. 18-003, HON 1290, Honors Exploration Seminar (New Course)

Dr. England presented the proposal and answered questions of the council.

Dr. Gronnvoll moved and Dr. Kronenfeld seconded the motion to open the item for discussion. The motion passed unanimously with the following revisions: Banner Coversheet: Correct Agenda item to 18-003; #6 check "On Demand" only; #9: NA; #15: Restrict course to honors students; Part 1 #2 complete sentence fragment; #4: strike hybrid sentence. Proposal approval dates needed.

V. Committee Reports:

 Dr. Gronnvoll and Dr. Abou-Zaid updated the Council on the progress of CASL to pilot a critical thinking rubric in a small number of general education courses. CASL also began discussions on implementing a quantitative reasoning rubric.

VI. Discussion:

1. Potential proliferation of General Education courses:

Provost Gatrell presented the following request:

The Office of Academic Affairs respectfully requests that CAA consider a moratorium on new General Education course proposals through December 2018 (or later depending on the determination of the General Education sub-committee or CAA) to facilitate the development of a faculty-led governance framework for the approval of proposed general education course that:

- Ensures student learning outcomes are consistent and assessed across the program;
- Potentially includes a formal process for the General Education sub-committee to review all proposals and make a recommendation to the CAA on approval;
- Recognizes reduced instructional resources and minimizes the expansion of approved courses through the development of a governing policy or standard practice that might, for example, limit the number of general education offerings by discipline or require new additions be accompanied by eliminations within a discipline or another practice the sub-committee deems appropriate; and
- Includes a periodic review (perhaps every three years) of approved General Education courses based on an approved learning outcomes rubric which may lead to recertification of existing courses, or remove of a General Education course designation in appropriate situations, and establish a timeline for the inaugural review cycle.

Discussion followed, and it was agreed that CAA could establish a General Education subcommittee led by Dr. Throneburg. Dr. Ruholl agreed to take a look at CAA's meeting schedule with a view to scheduling CAA and the General Education subcommittee on alternating weeks.

Provost Gatrell agreed to submit a formal proposal to be added to the January 25, 2018 agenda.

2. Faculty Senate invitation to CAA for discussion about issues that are being addressed by CAA and upcoming items that CAA has under consideration; as well as potentially revamping shared governance structures.

Dr. Ruholl has been invited to speak to Faculty Senate at their January 23rd meeting. The Council discussed items CAA is currently working on, and Dr. Ruholl extended the invitation to attend to the rest of the council.
